## "THE ROLE AND IMPORTANCE OF FAMILY AND MARRIAGE IN HUMAN LIFE"

**Abstract:** This article describes the role and importance of marriage in human life, the sanctity of family and marriage, the legal documents adopted in our country and the reforms implemented in our country to eliminate these issues.

**Key words:** Marriage, family, state and society, Family Code, sanctity of marriage, dissolution of marriage, family disputes, divorce.

Family is definitely the essence of human life. No matter what achievements or failures every person has had in his life, the influence of the family in the first place is strong in this case. Today, family issues are in the center of everyone's attention in our country. That is why the government of Uzbekistan considers family and family issues to be the most important task at the level of state policy. Of course, this is also stated in the Constitution of the Republic of Uzbekistan, which is our main law. Chapter XIV of the Constitution is called "Family", and its articles guarantee the most basic legal concepts about the family, the rights, freedoms and duties of parents and children in the family, and the protection of the family by the state. Article 63 of this law:

"The family is the main link of the society and has the right to be under the protection of the society and the state.

"Marriage is based on the voluntary consent of the parties and equal rights." - is indicated.

Of course, family issues are among the most urgent problems. From this we can see that the family is protected and guaranteed by the state and society. But now let's turn our attention away from this topic and focus on marriage and its structure, sanctity of marriage, its place and importance in human life.

Marriage is a union formed on the basis of mutual consent of representatives of two sexes. Of course, the consent of both parties is assumed when concluding a marriage. No one can force anyone to get married. If forced marriage and similar situations occur, this will be the basis for taking responsibility before the law. As the great French philosopher N. Chamfor said: "As smoke emerges from a flame, so does marriage blend into love." Based on the opinions of this scientist, mutual love between the two parties is of great importance in the formation of marriage.

Article 13 of the Family Code of the Republic of Uzbekistan:

"Marriage is optional. In order to enter into marriage, the future couple must have the ability to freely express their consent. Forced marriage is prohibited." is defined as It is clear from this that it is strictly forbidden to force a person into marriage if he does not want it. According to the relevant articles of the Family Code of the Republic of Uzbekistan, marriage is concluded voluntarily upon reaching marriageable age. Even if the marriage is not officially formalized, heavy fines are imposed for violation of the marriage age requirement according to the following article of the Code of Administrative Responsibility. Article 47-3 of the Code of Administrative Responsibility:

"Actually entering into marital relations with a person who has not reached the age of marriage, -

shall result in a fine of five to ten times the base calculation amount.

Giving away or marrying a person who has not reached marriageable age by parents or their substitutes, -

will result in a fine of seven to fifteen times the base calculation amount.

Carrying out a religious ceremony to conclude a marriage with a person who has not reached the age of marriage, -

causes a fine in the amount of ten to twenty times of the base calculation amount" We can say that for the family to be strong and healthy, the age of the parties to the marriage is very important. Because this is the most important pre-marriage factor. According to the legislation, the age of marriage is set at eighteen for men and women. If there are valid reasons, in special cases, such as pregnancy, child birth, and a minor is declared legally competent, at the request of those who wish to enter into marriage, the mayor of the relevant district, city may reduce the marriage age to a maximum of one. can be reduced per year.

Nowadays, the most urgent topic in our society is problems such as family breakdown, divorce, and marriage breakdown. The origin of family disputes and the occurrence of rulings as a result of it attract the attention of the general public, and necessary measures are being implemented in order to find a solution to the problem and prevent it. At the same time, the origin of family conflicts and the breakdown of marriage are problems such as the incompatibility of the spouse's character, childlessness, the inability to manage the family budget wisely, jealousy and distrust, the interference of the elders in the family, parents and relatives in the marital relationship. causing conflicts in family relations.

The issue of family strength and family-marriage relations has been the most urgent issue in all times. At this point, let's look at the words of Shaykh Muhammad Sadiq Muhammad Yusuf in his book "Happy Family":

"It is known that the family is the starting cell of every society. If the family is strong, peaceful, honest and pure, the society will be peaceful, strong and prosperous. On the contrary, if there is disorganization and destruction in families, if there is no difference between honest and profane, that society will be destroyed, peace will be lost, and in the end it will go into a deep decline. Yes, of course, the development of the state and society depends on the strength and well-being of the family. If relationships in the family are
