One of the most pressing issues is the occurrence of the most common offenses among young people in the current period. Various measures to carry out important tasks aimed at ensuring the meaningful transfer of youth rights, systematic organization of preventive work aimed at preventing crime, preventing them from falling under the influence of various harmful currents, educating young people in the spirit of love for the motherland, ensuring their free time, as well as a sharp reduction in crimes such as, important work is being carried out on the premature prevention of violations.

In the growth and maturation of the sprouts of each younger generation, his family, neighborhood, place of study and work are important. Taking into account this rule, we will refer to the following mechanisms for the implementation of the Prevention of crime and offenses committed between young people and minors

Responsible for the execution of the deadlines of implementation mechanisms

1. In order to prevent crimes and offenses, the young people who committed the crime and committed this crime, the young people who committed crimes (offenses) in the mahallas inhabited by minors, the young people who were previously convicted and prone to committing crimes, the discussion of crimes between minors and their parents and the general public, neighborhood presidents, responsible leaders;

2. To deal with crime on the scale of each neighborhood, first of all, in which area, identifying the foci of crime on the streets and separating them separately.

3. The chairman of the neighborhood, the head of the uquv camps, directs an hour of time on each day to prevent crime.

4. Strengthening preventive measures in the same place with a group of young people and minors surfing in public places, streets and other places, taking into account the fact that bullying crimes are mainly committed by minors and young people;

5. In village, Hecht identifies young people and minors who do not work or study, who have previously committed some kind of offense, conduct appropriate preventive detention with them individually, and carry out measures to prevent the occurrence of such crimes or offenses in the future;

6. To carry out continuous activities to prevent cases of bullying crimes mainly between young people and underage students with the use of cold weapons.

In the implementation of the Prevention of crimes and offenses committed between young people and minors, there is an extensive use of the capabilities of the Internet World Information Network, practical measures (proposals) on the process of committing offenses and their elimination.

1. To prevent the further occurrence of crimes of a serious or extreme type committed by propaganda through the media, social networks;
2. Installation and connection of video surveillance devices to "crime foci", crowded places, apartments with an entrepreneurial, upper-income population layer;
3. Taking into account the fact that young people and minors spend a lot of time mainly on social networks and get into various religious streams in the result of this, and many other negative cases, take control of their hand phones, computers and other means (check)
